Terms and Conditions of the Contest

"Clear Sky"

1. DEFINITIONS

1.1. The terms used in these regulations shall have the following meanings:

a. **Organizer** – MPP Media Pay Plus Ltd (MPP), based at Arch. Makario III, 161; 5th Floor/ Office 5; 3027 Limassol, Cyprus, hereinafter referred to as the "organizer";

b. **Contest** – the contest organized under the name "Clear Sky" described in these regulations;

c. Regulations - these contest regulations;

d. Participant – a person meeting the requirements specified in point 3 of the regulations;

e. Laureate - a person who has won a prize in the contest;

f. **Contest Entry** – the participant must enter the contest by answering the questions in the survey and correctly filling out the entry form and sending it via the contest website;

g. **Contest Website** – the website at https://clearskideals.com/ where the contest is conducted. Using the website is free; however, it requires internet access;

h. Working Day – any day of the week from Monday to Friday, excluding public holidays;

i. **Personal Data** – personal data of the contest participants will be processed in accordance with applicable law;

j. **Contest Task** – involves filling out the survey.

2. GENERAL PROVISIONS

2.1. The contest is organized in the territory of the European Union.

2.2. The contest duration includes the period from January 1, 2024, to December 31, 2024, while the activities related to awarding and collecting prizes and handling complaints will end by February 28, 2025.

2.3. It's a random computerized prize drawing. The contest is conducted in compliance with the legal regulations in Cyprus, and its provisions apply to the entire territory of the European Union, as Cyprus is a member of the European Union.

3.1. Subject to point 3.3 of the regulations, any natural person who, at least on the day of the contest start, meets the following conditions may be a participant of this contest:

a) is at least 18 years old and has full legal capacity,

b) has a permanent place of residence in the United Kingdom,

c) has read the content of these regulations and accepted its provisions.

3.2. Entering the contest must be done in the manner indicated in the regulations. Failure to meet any of the entry conditions will result in the invalidity of the entry.

3.3. Employees of MPP Media Pay Plus Ltd (MPP) based in Limassol, Cyprus, and their families are not allowed to participate in the contest. "Family members" are defined as spouses, descendants, ascendants, persons in an adoptive relationship, stepchildren, sons-in-law, daughters-in-law, siblings, stepfathers, stepmothers, and parents-in-law. Each person may participate in the contest only once.

4. CONTEST RULES

4.1. Each person meeting the conditions specified in point 3.1 of the regulations who wishes to participate in the contest must:

- read the provisions of these regulations;

- complete the survey;

- enter the contest by sending the entry via the contest website in accordance with point 4.2 of the regulations, within the deadline specified in point 4.6 of the regulations.

4.2. Participants who wish to enter this contest must submit their entry via the entry form on the contest website by providing the following data and statements:

- participant's mobile phone number (contact),

- participant's email address,
- complete the survey,
- check the following statements in the entry form:

"I have read the regulations of the "Clear Sky" contest, including the information clause regarding the processing of personal data contained in the regulations, and I accept all its provisions."

"I declare that I am over 18 years old and have full legal capacity."

Before submitting the entry form, the organizer asks to carefully check the data and information provided in the form.

4.3. A participant may submit only one solution to the contest task, i.e., one survey, and is entitled to receive only one prize in the contest. Participation through automated mass entry procedures is excluded.

4.4. After submitting a valid contest entry, the participant is registered in the contest database. The participant will receive confirmation of the correct entry and registration in the contest database by displaying information confirming the correct entry on the contest website and additionally by receiving an email sent to the email address provided in the entry form, in accordance with point 4.2 of the regulations.

4.5. The participant must have a device with internet access equipped with an up-to-date web browser, e.g., Microsoft Edge, Chrome, Firefox, Safari, or Opera. The contest organizer is not responsible for the operation of telecommunication systems and/or devices independent of the organizer.

4.6. Contest entries can be submitted daily from 00:00:00 on January 1, 2024, to 23:59:59 on December 31, 2024.

5. SELECTION OF PRIZE WINNERS

5.1. Winners will be selected every quarter (three months) within 2 weeks after the closing date of MPP by free draw at random from all complete entries received and notified as such by email or phone.

6. PRIZES

6.1. Prizes will be made available every quarter of the year. Prizes will be sent free of charge to the specified residence in the UK. The winners will be listed in the winner section on the site.

6.2. The organizer reserves the right to adjust the promotional prize to another promotional prize of minimal similar (economic) value, in good consultation with the prize winner. If a similar prize and/or prize from a similar product group can be awarded at participating in a promotion, the Organizer discloses such after consulting the winner.

6.3. The prize winner consents in good consultation with the Organizer to the use of his/her name, place of residence, country, and eventual photograph on the websites of the organizer for post-promotional activities.

9.1. The condition for collecting each prize in the contest by its laureate is to provide the laureate's data necessary for sending the prize, including the full residence address in the UK.

10. COMPLAINT PROCEDURE

10.2. Each complaint should include: the participant's name and surname, exact address, detailed description and reason for the complaint, and the content of the demand. It may also include the participant's phone number and email address.

10.4. The complaint procedure is voluntary and does not exclude the right of the participant to independently pursue claims through legal proceedings.

11.1. The administrator of personal data is the contest organizer, MPP Media Pay Plus Ltd (MPP).

11.2. Personal data of contest participants will be processed solely for the purpose of organizing the contest in accordance with applicable law. We collect personal data for the purposes specified in the privacy policy.
